Poor authentication posture causes legitimate emails to be rejected or land in spam, silently breaking business communication.

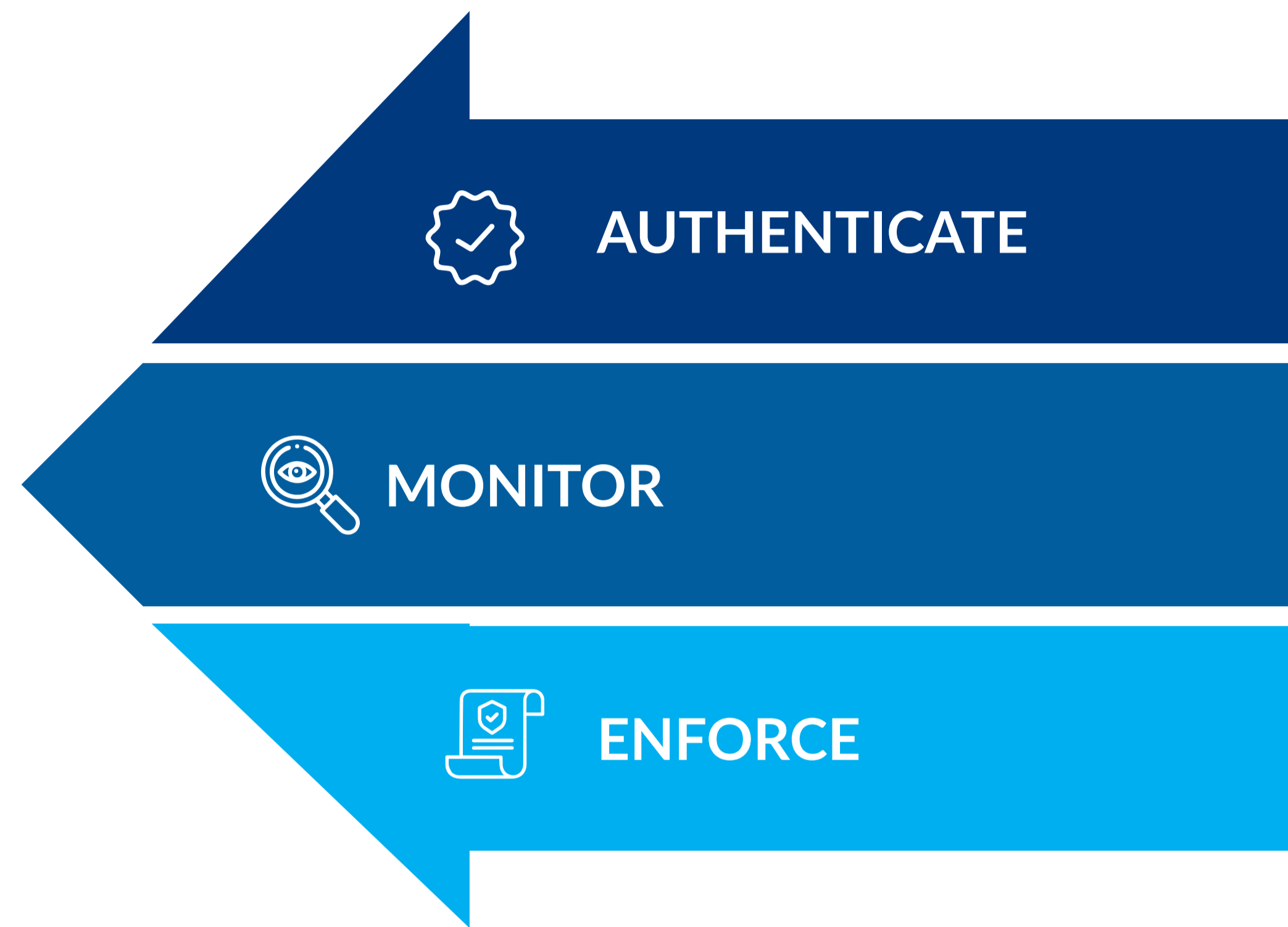

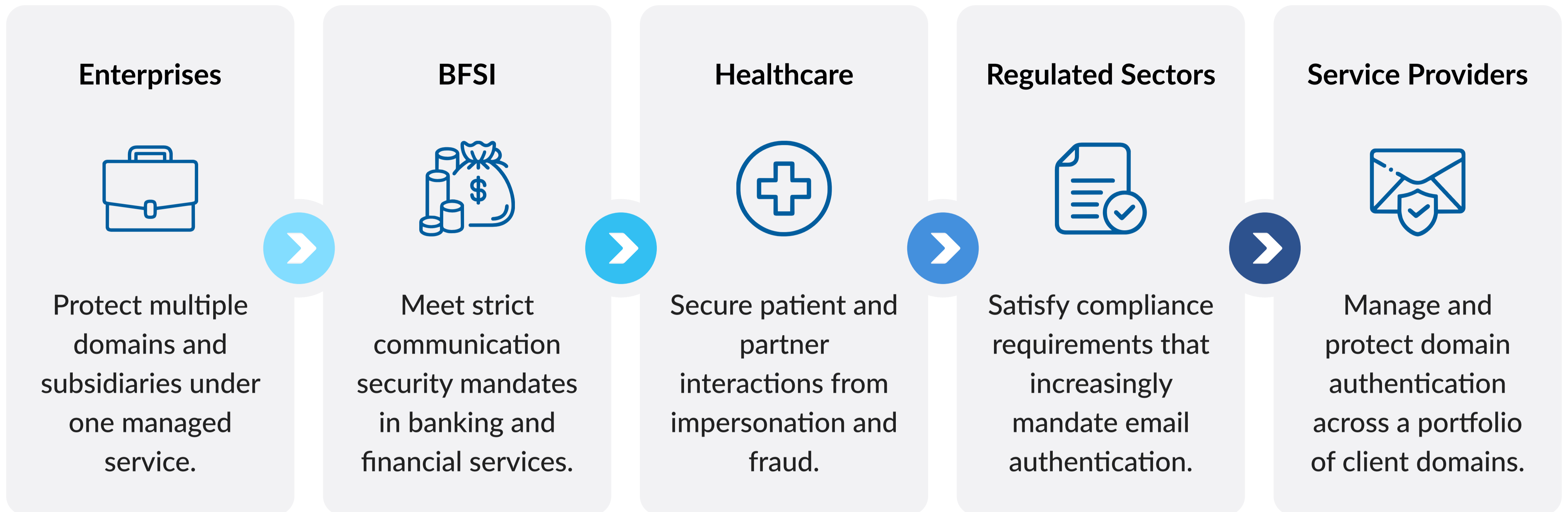
